Purpose

This document provides you with **key information about this investment product**. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a derivative contract in the form of a swap relating to interest rates.

Objectives

- The objective of this product is to exchange floating interest payments for fixed interest payments for an agreed period of time and may be used as a protection against rising interest rates.
- The product achieves its objective by you and Nordea agreeing to the terms of the Tomorrow Next or the Overnight Index Swap (as applicable), under which you agree to pay Nordea a fixed interest amount and Nordea agrees to pay you a floating interest amount for an agreed period of time.
- Payments under a Tomorrow Next Swap or an Overnight Index Swap (as applicable) consist solely of interest payments. The notional amount is used solely for calculating the interest payments, hence no exchange of notional amounts will be made under the Tomorrow Next or Overnight Index Swap (as applicable).
- The fixed interest amount that you must pay is based on a fixed interest rate that remains the same during the term of the product. The fixed interest amount is paid by you on pre-agreed payment dates and is calculated on the basis of the fixed interest rate multiplied with the notional amount and the day count fraction.
- The floating interest amount that you will receive is based on a floating interest reference rate that is determined on each trading day for the next interest period, which in respect to an Overnight Index Swap is from the current trading day to the next trading day or with respect to the Tomorrow Next Swap is from the following trading day to the next trading day. The floating interest amount is paid by Nordea on pre-agreed payment dates and is calculated on the basis of the compounded floating interest rate (plus, in the event this is agreed upon, a spread) multiplied with the notional amount and the day count fraction.
- The floating interest reference rate is specified to be either the official inter-bank fixing of the overnight rate or the Tomorrow/Next rate compounded over a specified term.
- The Overnight Index Swap (payer) is a bilateral agreement that cannot ordinarily be terminated unilaterally by either you or Nordea. It is a product that is entered into for its term, although early termination may occur in the event of a default of either you or Nordea. The agreement between you and Nordea provides that if certain exceptional events occur (1) Nordea may make adjustments to certain products and/or (2) Nordea or you may terminate the product early. These events are specified in more detail in the agreement between you and Nordea. The product may also be terminated upon mutual agreement. The amount (if any) you receive or pay on such early termination is likely to be different from the scenarios described in this document.
- Nordea and you may agree on an optional early termination for Nordea as part of the product terms. The optional early termination allows Nordea to terminate the product at specific dates prior to maturity for settlement at market value.
- You may not be able to terminate this product even though you or Nordea have terminated or discontinued a product or a commercial flow that this product is aimed to hedge.
- Illustrative terms are set out below, which are illustrative of the terms of a Overnight Index Swap (payer), but which do not reflect the exact terms you agree with Nordea. The exact terms will be set out in an individual trade confirmation.

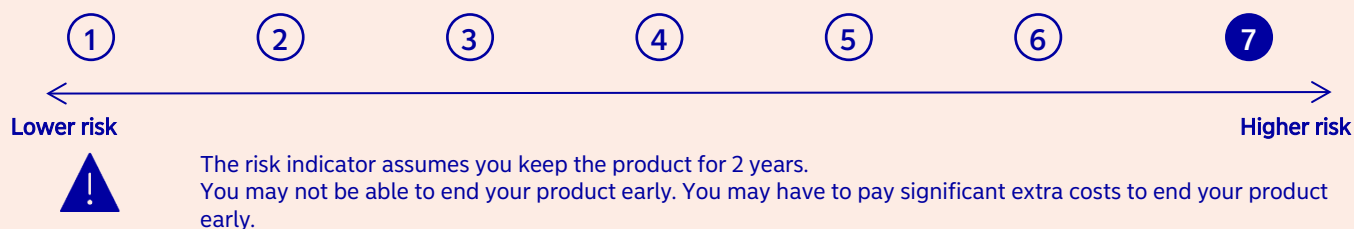

Intended retail investor

The product Overnight Index Swap (payer) is aimed at retail clients, who are interested in hedging and who have a short-term investment horizon of less than 3 years. The Overnight Index Swap (payer) is a product for informed investors or advanced investors.* The investor is able and willing to bear losses beyond the investment amount and puts no emphasis on capital protection. On a scale of risk ranging from 1 (very low risk tolerance; very low to low return) to 7 (very high risk tolerance; highest return) the product Overnight Index Swap (payer) falls in risk category 7.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of Nordea Bank AB (publ) to pay you. When this product is combined with other products or commercial positions, the total portfolio will have a different net risk profile. This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.

This table shows the money you could get back or pay over the next 2 years, under different scenarios, assuming that you invest 10 000 EUR. What happens if Nordea Bank AB (publ) is unable to pay out?

When buying the product you assume a credit risk on the issuer. In the event of the issuers bankruptcy, the holder of the product will have an unsecured claim versus the bank. Note that the product is not covered by any deposit guarantee scheme.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the recommended holding period. They include potential early exit penalties. The figures assume you invest 10 000 EUR. The figures are estimates and may change in the future.
