**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

<b>Type</b>	This product is a derivative contract in the form of an option to enter a swap relating to interest rates.
<b>Objectives</b>	<ul style="list-style-type: none"> <li>The objective of this product is to give you the right, but not the obligation, to receive the cash value (if positive) of an interest rate swap on a pre-agreed future date (expiry date) and it may be used as protection against falling interest rates on a future date.</li> <li>The product achieves its objective by you and Nordea agreeing to the terms of the swaption with cash settlement, under which you pay Nordea a premium in return for the right to receive on the expiry date of the swaption the cash value at that time of an underlying interest rate swap (the underlying interest rate swap) under which Nordea would pay you a fixed interest amount and you would pay Nordea a floating interest amount for an agreed period of time.</li> <li>The underlying interest rate swap is used solely for calculating a cash value and you will not enter into the underlying interest rate swap.</li> <li>The terms of the underlying interest rate swap are pre-agreed, including the fixed rate (the strike price), the floating interest reference rate, the notional amount, the start date, payment dates and the maturity date. At the expiry date you can decide whether you want to exercise the swaption. If on the expiry date of the swaption the market rate of a corresponding interest rate swap is below the strike price you will receive the cash value of the underlying interest rate swap from Nordea if you choose to exercise the swaption. The cash value is calculated by discounting the future cash flows stemming from the difference between the strike price and the market rate of a corresponding interest rate swap. If the market rate of a corresponding interest rate swap is above the strike price, the interest rate swap will have a value of zero and you will not receive any payment.</li> <li>Payments under a swaption consist of an upfront payment that you pay to Nordea for the right to receive the cash value of the underlying interest rate swap. There are no interest payments during the swaption's lifetime. The notional amount is used as the basis for calculating the cash value of the swaption and the underlying interest rate swap. Whether or not you exercise the right to receive the cash value of the underlying interest rate swap, the premium you paid will not be returned.</li> <li>The Swaption with Cash Settlement (receiver) is a bilateral agreement that cannot ordinarily be terminated unilaterally by either you or Nordea. It is a product that is entered into for its term, although early termination may occur in the event of a default of either you or Nordea. The agreement between you and Nordea provides that if certain exceptional events occur (1) Nordea may make adjustments to certain products and/or (2) Nordea or you may terminate the product early. These events are specified in more detail in the agreement between you and Nordea. The product may also be terminated upon mutual agreement. The amount (if any) you receive or pay on such early termination is likely to be different from the scenarios described in this document.</li> <li>Nordea and you may agree on an optional early termination for Nordea as part of the product terms. The optional early termination allows Nordea to terminate the product at specific dates prior to maturity for settlement at market value.</li> <li>You may not be able to terminate this product even though you or Nordea have terminated or discontinued a product or a commercial flow that this product is aimed to hedge.</li> <li>Illustrative terms are set out below, which are illustrative of the terms of a Swaption with Cash Settlement (receiver), but which do not reflect the exact terms you agree with Nordea. The exact terms will be set out in an individual trade confirmation.</li> </ul>

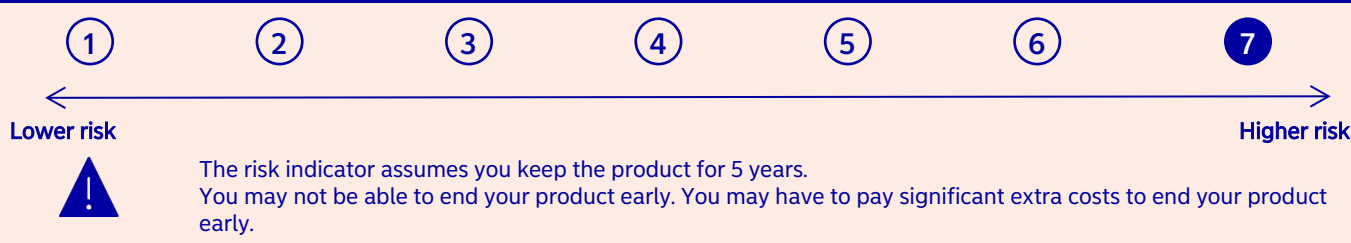

#### Intended retail investor

The product Swaption with Cash Settlement (receiver) is aimed at retail clients, who are interested in hedging and who have a long-term investment horizon of more than 5 years. The Swaption with Cash Settlement (receiver) is a product for informed investors or advanced investors.\* The investor is able and willing to bear losses beyond the investment amount and puts no emphasis on capital protection. On a scale of risk ranging from 1 (very low risk tolerance; very low to low return) to 7 (very high risk tolerance; highest return) the product Swaption with Cash Settlement (receiver) falls in risk category 7.

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of Nordea Bank Abp to pay you.

When this product is combined with other products or commercial positions, the total portfolio will have a different net risk profile. This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.

This table shows the money you could get back or pay over the next 5 years, under different scenarios, assuming that you invest 10 000 EUR. ## What happens if Nordea Bank Abp is unable to pay out?

When buying the product you assume a credit risk on the issuer. In the event of the issuers bankruptcy, the holder of the product will have an unsecured claim versus the bank. Note that the product is not covered by any deposit guarantee scheme.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the recommended holding period. They include potential early exit penalties. The figures assume you invest 10 000 EUR. The figures are estimates and may change in the future.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This product is designed for staying invested until the maturity date.
